**RELEASE OF SECURITY INTEREST IN THE RELEASED COPYRIGHTS, PATENTS
AND TRADEMARKS**

THIS RELEASE OF SECURITY INTEREST IN THE RELEASED COPYRIGHTS, PATENTS AND TRADEMARKS (this "Release"), made as of April 21, 2011, is granted by CANADIAN IMPERIAL BANK OF COMMERCE, through its New York agency, in its capacity as collateral agent pursuant to the Credit Agreement (as defined below) (in such capacity, the "Collateral Agent") in favor of the Borrower and the Guarantors and their respective successors and assigns party to the Security Agreements described below (collectively, the "Pledgors").

WHEREAS, NaviSite, Inc. (the "Borrower"), the Subsidiary Guarantors party thereto (collectively, the "Guarantors"), CANADIAN IMPERIAL BANK OF COMMERCE, through its New York agency, as Administrative Agent and Collateral Agent, and the lenders from time to time party thereto have entered into that certain Amended and Restated Credit Agreement, dated as of September 12, 2007 (as amended, supplemented or otherwise modified from time to time, the "Credit Agreement");

WHEREAS, pursuant to the terms and conditions of certain Patent Security Agreements, Trademark Security Agreements and Copyright Security Agreements, including, without limitation, those certain Patent Security Agreements, Trademark Security Agreements, and Copyright Security Agreements set forth on Schedule I attached hereto, between the Pledgors party thereto and the Collateral Agent (the "Security Agreements"; all capitalized terms used but not defined herein shall have the respective meanings ascribed thereto in the Security Agreements), the Pledgors granted to the Collateral Agent a security interest in all of right, title and interest in, to and under the Pledged Collateral therein, including, without limitation, the Patent registrations and applications set forth on Schedule II hereto (the "Released Patents"), the Trademark registrations and applications set forth on Schedule III hereto (the "Released Trademarks") and the Copyright registrations and applications set forth on Schedule IV hereto (the "Released Copyrights" and, together with the Released Patents and Released Trademarks, the "Released IP");

WHEREAS, the Security Agreements relating to the Released IP have been recorded with the (1) Assignments Division of the U.S. Patent and Trademark Office on (A) September 12, 2007 at Reel 019541 and Frame 0809, (B) July 12, 2007 at Reel 003578 and Frame 0815, (C) June 26, 2008 at Reel 003803 and Frame 0860, (D) September 17, 2007 at: (i) Reel 003622 and Frame 0482 and (ii) Reel 003622 and Frame 0388 and (2) U.S. Copyright Office on (A) June 18, 2007 at Volume 3553 and Document no. 89 and (B) September 17, 2007 at Volume 3555 and Document No. 688; and

WHEREAS, the Pledgors have paid all of their outstanding indebtedness under the Credit Agreement which is secured by the Security Agreements and have requested that the Collateral Agent release its security interest in the Released IP;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby terminates the

Security Agreements, and hereby terminates, cancels, re-pledges, reassigns and releases any and all security interests it has against the Released IP, without warranty or recourse.

If and to the extent the Collateral Agent has acquired any right, title or interest to any of the Released IP, it hereby assigns and transfers such rights, title or interest to the respective Pledgors. The Collateral Agent shall take all further actions, and provide to the Pledgors and their successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Pledgors to more fully and effectively effectuate the purposes of this Release.

This Release shall be construed in accordance with and governed by the law of the State of New York.
