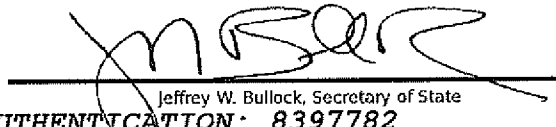

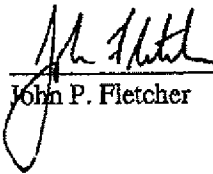
First. The name of the limited liability company is Windstream Hosted Solutions, LLC.
