

1. I am President of Bridge Machine Company, Inc. ("Bridge"). I submit this affidavit pursuant to TMEP Section 503.06(c) to correct and remove a document that was improperly recorded against the above-referenced trademark registration (the "Registration").

2. Bridge is the correct owner of the Registration, and no interest in the Registration or the trademark has been assigned to any third party as of the date hereof. The initial Application Ser. No. 73/124,471 (the "Application") was filed by Bridge on April 27, 1977. Bridge has been and continues to be the owner of the Application and the Registration from the filing date until the date hereof.

3. An assignment document was improperly recorded against the Mark on December 3, 1982 at Reel/Frame 0405/0046. This previously recorded document was submitted with erroneous information, specifically an erroneous assignment of the Mark by White Motor Corporation, who had and has no right or interest in the Mark.

4. Upon information and belief, White Motor Corporation had or has an interest in Registration No. 1,103,749 for WM in stylized form and through scrivener's error recorded the previous assignment with the similar, but incorrect registration number, of the Registration.



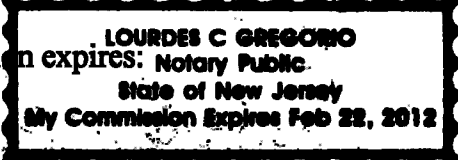
