TRADEMARK ASSIGNMENT AGREEMENT


This Trademark Assignment Agreement, effective as of the latter date of execution below, is between (i) David Healey, a U.S. citizen doing business as Patentmath, with an address of 11 Rainford Ct., Sugar Land, Texas 77479 ("Healey") and (ii) Fish & Richardson P.C., a Massachusetts professional corporation with a business address of One Marina Park Drive, Boston, MA 02210 ("F&R").

WHEREAS Healey is the owner of a pending federal trademark application at the U.S. Patent and Trademark Office for the mark PATENTMATH (the "Mark") for "plans for intellectual property" (Ser. No. 85/252,741);

WHEREAS Healey desires to assign to F&R its ownership interest in the Mark and trademark application referenced above, together with the goodwill of the ongoing and existing business to which the Mark pertains, pursuant to 15 U.S.C. § 1060.

NOW, THEREFORE, in consideration of the mutual promises set forth below and other good and valuable consideration, the receipt of which is hereby acknowledged, the parties hereby agree as follows:


1. Healey does hereby sell, assign, and transfer to F&R the entire worldwide right, title, and interest in and to the Mark and trademark application referenced above and any others that may have been filed for the Mark, as well as the right to recover for any past infringements, together with the goodwill of the business symbolized by the Mark and that portion of the ongoing and existing business of Healey to which the Mark pertains, as required under 15 U.S.C. § 1060.
2. Healey shall do all acts and execute all documents that may be reasonably required by F&R in order to effect the assignment of the Mark and trademark application referenced above and to record the assignment.
