**RELEASE OF SECURITY INTEREST**

This RELEASE is made by WELLS FARGO BANK, N.A. ("Wells Fargo"), successor-by-merger to Wachovia Bank, National Association, as Administrative Agent, in favor of LIBERTY GROUP CORNING HOLDINGS, INC. ("Corning") as follows:
