RELEASE OF SECURITY INTEREST

This RELEASE is made by WELLS FARGO BANK, N.A. ("Wells Fargo"), successor-by-merger to Wachovia Bank, National Association, as Administrative Agent, in favor of LIBERTY GROUP FREEPORT HOLDINGS, INC. ("Freeport") as follows:
