**TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT**

**THIS TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT** (this "Termination"), is dated as of April 22, 2011, and made by **WELLS FARGO CAPITAL FINANCE, INC.**, a California corporation formerly known as Wells Fargo Foothill, Inc., having an office at 2450 Colorado Avenue, Suite 3000 West, Santa Monica, CA 90404 ("Grantee") to La Madeleine, Inc., a Texas corporation ("Grantor"), with its chief executive office at 6688 North Central Expressway, Suite 700, Dallas, TX 75206

WHEREAS, pursuant to that certain Trademark Security Agreement] dated as of April 24, 2006, made by Grantor in favor of Grantee (the "Security Agreement"), a security interest was granted by the Grantor to Grantee in certain collateral, including the Trademarks (as hereinafter defined);

WHEREAS, the Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on April 26, 2006, at Reel 003297 and Frame 0750; and

WHEREAS, Grantee now desires to terminate and release the Security Agreement;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, Grantee hereby states as follows:

1. Definitions. The term "Trademarks," as used herein, shall mean all of the Grantor's right, title and interest of every kind and nature as of the date hereof in the trademarks listed on Schedule A hereto.

2. Release of Security Interest. Grantee hereby terminates the Security Agreement and terminates, releases and discharges its security interest in the Trademarks and reassigns to the person or persons legally entitled thereto all right, title and interest of Grantee in the Trademarks.
