TRADEMARK RELEASE

This Release is granted as of April 21, 2011 by DEUTSCHE BANK AG LONDON (the "Security Agent"), with principal offices at 1 Great Winchester Street, London, EC2N 2DB, United Kingdom, to Elster AMCO Water, LLC (formerly known as AMCO Water Metering Systems, Inc.), a Florida corporation with principal offices at 1100 SW 38th Avenue, Ocala, FL 34482 (the "Grantor"), as follows:

W I T N E S S E T H:

WHEREAS, the Grantor has heretofore granted to the Security Agent a security interest in certain U.S. trademarks, trademark registrations and trademark applications as more particularly set forth on Schedule A attached hereto (the "Marks") to secure the Secured Obligations (as defined in the Security Agreement, dated as September 15, 2005, among the Security Agent, the Grantor and the other assignors party thereto from time to time (as amended from time to time, the "Security Agreement")); and

WHEREAS, the Security Agent wishes to release and restore all right, title and interest in and to the Marks to the Grantor and to dissolve any and all liens and encumbrances respecting the Marks shown on the attached Schedule A hereto.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Agent hereby releases, discharges, quit claims and relinquishes unto the Grantor any and all right, title and interest in and to the Marks, and more particularly, (i) the security interest in the trademarks, trademark registrations and trademark applications as set forth on Schedule A hereto, (ii) all Proceeds (as such term is defined in the Security Agreement referred to above) and products of the Marks, (iii) the goodwill of the business with which the Marks are associated and (iv) all causes of action arising prior to or after September 15, 2005 for infringement of any of the Marks or unfair competition regarding the same, and granted to the Security Agent by the Grantor by the Security Agreement, which Assignment was duly recorded on October 7, 2005 at Trademark Reel 003172, Frame 0078 in the United States Patent and Trademark Office.
