SUPPLEMENT NO. 1 TO THE TRADEMARK SECURITY
AGREEMENT DATED AS OF MAY 24, 2006

WHEREAS, pursuant to the terms of the Amended and Restated Credit Agreement, dated as of April 15, 2011 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Restated Credit Agreement"), among CKX, Inc., a Delaware corporation (the "Borrower"), the several banks and other financial institutions or entities from time to time parties thereto as lenders (the "Lenders") and JPMorgan Chase Bank, N.A., as administrative agent for the Lenders (in such capacity, together with its successors and permitted assigns in such capacity, the "Administrative Agent") and collateral agent for the Secured Parties (as defined therein) (in such capacity, together with its successors and permitted assigns in such capacity, the "Collateral Agent"), the Lenders have agreed to make extensions of credit to the Borrower upon the terms and subject to the conditions set forth therein;

WHEREAS, pursuant to the Guarantee and Collateral Agreement, dated as of May 24, 2006 (as supplemented by the Assumption Agreement (as defined below) and by the Reaffirmation Agreement (as defined below), and as further amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Guarantee and Collateral Agreement"), by and among the Borrower, the subsidiary guarantors party thereto (the "Guarantors") and Bear Stearns Corporate Lending Inc. (the "Existing Agent"), the Borrower and the Guarantors assigned and transferred to the Existing Agent a security interest in certain properties set forth therein;

WHEREAS, pursuant to the Trademark Security Agreement, dated as of May 24, 2006 (as supplemented by the Assignment and Assumption Agreement (as defined below) and as further amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Trademark Security Agreement"), by and among 19 Entertainment Limited (the "Existing Grantor"), pursuant to which the Existing Grantor granted to the Existing Agent (for the benefit of itself and the Lenders), as security for the Existing Grantor's Obligations or for its obligations under and in connection with its guarantee of the Borrower's Obligations pursuant to the Guarantee and Collateral Agreement, a continuing security interest in all of the Existing Grantor's right, title and interest in, to and under all of the Trademarks and Trademark Licenses listed on Schedule 1 thereunder, all goodwill associated therewith and all proceeds of any and all of the foregoing, pledged to the Existing Agent (for the benefit of itself and the Lenders) pursuant to the Guarantee and Collateral Agreement;

WHEREAS, pursuant to the Assignment and Assumption Agreement, dated as of April 15, 2011 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Assignment and Assumption Agreement"), by and among the Collateral Agent, the Existing Agent, the Existing Grantor, All Girl Productions, J2K Productions, Inc., 19 TV Limited, 19 Management Limited, Focus Enterprises, Inc., and 19 Recordings Limited, the Existing Agent irrevocably assigned to the Collateral Agent all of the Existing Agent's interest in, rights and obligations under the Trademark Security Agreement;

WHEREAS, pursuant to the Assumption Agreement, dated as of April 15, 2011 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Assumption Agreement"), by and among Native Management Limited, Native Songs Limited, Double Vision Film Limited, Freedom Media Limited, Freedom TV Limited, This Land Productions, Inc., CTA Productions, Inc., Masters of Dance Productions Inc., SYTYCD DVD Productions, Inc., CKX Holding Corp., IICD, LLC, The Comedy Hall of Fame, LLC, and 19 Entertainment Worldwide LLC (the "Additional Grantors"), the Additional Grantors have joined as parties to and have assumed the rights and obligations of "Grantors" under the Guarantee and Collateral Agreement (together with the Existing Grantor, the "Grantors") and under the Trademark Security Agreement;

WHEREAS, pursuant to the Reaffirmation Agreement, dated as of April 15, 2011 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Reaffirmation Agreement”), among the Reaffirming Parties (as defined therein) and the Collateral Agent, each Reaffirming Party reaffirmed its payment obligations, guarantees, pledges, grants of security interests and other obligations under each of the Loan Documents (as defined in the Restated Credit Agreement) to which is it a party;

WHEREAS, the Grantors have registered additional Trademarks and/or Trademark Licenses since the date of execution of the Trademark Security Agreement;

WHEREAS, the Trademarks and Trademark Licenses listed in Schedule 1 to the Trademark Security Agreement immediately prior to giving effect to the Restated Credit Agreement do not reflect all the Trademarks and Trademark Licenses held by the Grantors as of the date hereof;

THEREFORE,

A. The parties listed in Annex A hereby join as parties to the Trademark Security Agreement and assume the rights and obligations of “Grantors” thereunder;

B. Each of the Grantors does hereby grant to the Collateral Agent (for the benefit of the Secured Parties), as security for such Grantor’s Obligations or for its obligations under and in connection with its guarantee of the Borrower Obligations pursuant to the Guarantee and Collateral Agreement, a continuing security interest in and to all of such Grantor’s right, title and interest in, to and under all Trademarks and Trademark Licenses being added to Schedule 1 of the Trademark Security Agreement pursuant to Annex B below, all goodwill associated therewith, and all proceeds of any and all of the foregoing; and

C. The Trademark Security Agreement is hereby supplemented, effective as of the date hereof, by: 1) joining the entities listed in Annex A as parties thereto, with all the rights and obligations of “Grantors” thereunder; and 2) amending Schedule 1 thereof by including the Trademarks and Trademark Licenses listed on Annex B hereto, so as to reflect all of the Trademarks and Trademark Licenses granted to the Collateral Agent (for the benefit of the Secured Parties) pursuant to the terms of the Trademark Security Agreement and the Guarantee and Collateral Agreement.

Except as expressly supplemented hereby, the Trademark Security Agreement shall continue in full force and effect in accordance with the provisions thereof. As used in the Trademark Security Agreement, the terms “Agreement”, “this Agreement”, “this Trademark Security Agreement”, “herein”, “hereafter”, “hereto”, “hereof” and words of similar import, shall, unless the context otherwise requires, mean the Trademark Security Agreement as supplemented by this Supplement.

Except as expressly supplemented hereby, the Trademark Security Agreement, all documents contemplated thereby and any previously executed Supplements thereto, are each hereby confirmed and ratified by each of the Grantors.

The execution and filing of this Supplement, and the addition of the Trademarks and Trademark Licenses set forth herein are not intended by the parties to derogate from, or extinguish, any of the Collateral Agent’s rights or remedies under (i) the Trademark Security Agreement and/or any agreement, amendment or supplement thereto or any other instrument executed by any Grantor and heretofore recorded or submitted for recording in the U.S. Patent and Trademark Office, or (ii) any financing

statement, continuation statement, deed or charge or other instrument executed by any Grantor and heretofore filed in any state or county in the United States of America or elsewhere.

Capitalized terms used herein and not otherwise defined shall have the meaning set forth in the Trademark Security Agreement and if not therein defined, in the Guarantee and Collateral Agreement.

IN WITNESS WHEREOF, each of the Grantors has caused this Supplement No. 1 to the Trademark Security Agreement to be duly executed as of April 15, 2011.
