**ARTICLES OF INCORPORATION  
WITH STATEMENT OF CONVERSION**

**ONE:** The name of this corporation is:

**LOT 26 STUDIO, INC.**

**TWO:** The purpose of this corporation is to engage in any lawful act or activity for which a corporation may be organized under the General Corporation Law of California other than the banking business, the trust company business or the practice of a profession permitted to be incorporated by the California Corporations Code.

**THREE:** The name and address in the State of California of this corporation's initial agent for service of process is:

**FOUR:** This corporation is authorized to issue only one class of shares; and the total number of shares which the corporation is authorized to issue is Ten Million (10,000,000).

**FIVE:** The name of the converting California limited liability company is **LOT 26 STUDIO, LLC**. The limited liability company's California Secretary of State file number is 200721310059. The principal terms of the plan of conversion were approved by a vote of the members, which equaled or exceeded the vote required under Section 17540.3. There is no class of members entitled to vote and the percentage vote required is a majority in interest of the members. The limited liability company is converting to a California stock corporation.

**SIX:** The liability of directors of the corporation for monetary damages shall be eliminated to the fullest extent permissible under California law.

The corporation is authorized to provide indemnification of agents (as defined in Section 317 of the California Corporations Code) through Bylaw provisions, agreements with agents, vote of shareholders or disinterested directors, or otherwise, to the fullest extent permissible under California law.
