RELEASE OF TRADEMARKS SECURITY INTEREST

THIS RELEASE dated as of April 27, 2011, by Spicewood Holdings LLC, as Collateral Agent (as defined below) for the Lenders. Terms used herein and not otherwise defined shall have the meanings assigned to such terms in the Credit Agreements referred to below, as applicable.

A. Reference is made to the Term Loan Agreement dated as of January 11, 2010 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Term Loan Agreement"), among Open Link Financial, Inc., a Delaware corporation (the "Borrower"), OLF Intermediate Holdings, Inc., a Delaware corporation, the several banks and other financial institutions or entities from time to time party thereto (the "Lenders") and Spicewood Holdings LLC, as Collateral Agent (in such capacity, the "Collateral Agent") and administrative agent.

B. Reference is made to the Guarantee and Collateral Agreement, dated as of January 11, 2010 (as amended, supplemented or otherwise modified from time to time, the "Guarantee and Collateral Agreement"), among the Borrower, the subsidiary guarantors party thereto and the Collateral Agent, pursuant to which, among other things, the Borrower granted a security interest to the Collateral Agent, for the benefit of certain secured parties named therein, in, among other things, the registered trademarks of the Borrower (the "Trademarks"), which security interest was recorded with the United States Patent & Trademark Office at Reel 004131/0428 on January 14, 2010.

C. In connection with the termination of the Credit Agreements, the Borrower has informed the Collateral Agent of its desire to obtain the release of all right, title and interest of the Collateral Agent, the Lenders and each other grantee or beneficiary in and to the Trademarks granted under the Guarantee and Collateral Agreement.


Accordingly, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, all the Collateral Agent's right, title and interest (including, without limitation, security interests) in and to the Trademarks pursuant to the Guarantee and Collateral Agreement shall automatically terminate as provided in the Guarantee and Collateral Agreement, including, without limitation, the Trademarks set forth on Annex I attached hereto, the debt secured thereby having been paid and satisfied in full and any right, title or interest of the Collateral Agent in such Trademarks shall hereby cease and become void.
