TRADEMARK ASSIGNMENT made on April 15, 2011, from Raiffeisen Bank International AG ("Assignor") to Raiffeisen Zentralbank Österreich Aktiengesellschaft ("Assignee"), each being an Austrian corporation and each having an address at Am Stadtpark 9, A-1030 Vienna, Austria.

WHEREAS:

(A) The Assignor is the beneficial and registered owner in the United States of America of a design trademark consisting of a stylized gable cross and the block letter trademark "Raiffeisen," each as further described in Schedule A hereto (the "Trademarks").

(B) The Assignor has agreed to assign the Trademarks to the Assignee for the consideration set out in this Assignment.

IT IS AGREED AS FOLLOWS:

1. In consideration of the sum of \$10.00, receipt of such sum being confirmed by the Assignee, the Assignor hereby assigns as legal and beneficial owner to the Assignee all its right, title and interest in and to the Trademarks, free from any liens, claims or encumbrances, together with all statutory and common law rights attaching thereto, including without limitation the right to sue for damages and other remedies in respect of any infringement or misuse of the Trademarks which may have occurred prior to the date of this Assignment and to retain any damages obtained as a result of any such action.

2. The Assignor confirms that this Assignment is made with the goodwill attaching to the Trademarks as of the date hereof.




4. This Assignment is governed by and shall be construed in accordance with the laws of the State of New York.




