**TERMINATION AND RELEASE
OF SECURITY INTEREST IN TRADEMARK COLLATERAL**

This Termination and Release of Security Interest in Trademark Collateral ("**Termination and Release**") is granted, conveyed and delivered as of this 18 day of March, 2011, by WILLIAM GRANT & SONS, INC., a New Jersey corporation, having a principal address at 200 Park Avenue South, Suite 2118, New York, New York 10003-1503 ("**Secured Party**"), in favor of SPIRITS INTERNATIONAL B.V. (formerly Spirits International N.V.), a Netherlands private limited liability company, having its effective place of management at 7, rue Nicolas Bové, Luxembourg L-1253 ("**SPI BV**"), and being duly represented by its Geneva branch,

WHEREAS, SPI BV and Secured Party, among others, are parties to that certain Supply, Distribution and Brand Management Agreement dated November 7, 2008, as amended, modified, and supplemented on December 23, 2008, April 16, 2009, May 10, 2009, November 9, 2009 and September 20, 2010 and March 18, 2011 (as amended, the "**Distribution Agreement**");

WHEREAS, pursuant to the terms of the Distribution Agreement, Secured Party paid a related entity of SPI BV the Prepayment Amount (as such term is defined in the Distribution Agreement);

WHEREAS, in accordance with the terms of the Distribution Agreement and to secure the repayment of the Prepayment Amount, SPI BV and Secured Party entered into that certain Trademark Security Agreement dated November 7, 2008 ("**Trademark Security Agreement**"), pursuant to which (a) SPI BV granted Secured Party a first priority lien and continuing security interest in and to certain Trademark Collateral (as such term is defined in the Trademark Security Agreement), including the trademark registrations set forth on Schedule A attached hereto ("**Registered Marks**"), and (b) Secured Party recorded such security interest against said Registered Marks with the United States Patent and Trademark Office on December 15, 2008 at Reel 3903, Frame 0510; and

WHEREAS, SPI BV's related entity has fully repaid the Prepayment Amount in accordance with the terms of the Distribution Agreement and therefore in accordance with the terms of the Trademark Security Agreement the parties hereto desire to record this instrument to confirm and evidence the full repayment of, and satisfaction of all obligations with respect to, the Prepayment Amount and the termination and release of the first priority lien and continuing security interests held by Secured Party in, to and under all Trademark Collateral, including the Registered Marks.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which SPI BV and Secured Party hereby acknowledge, the parties acknowledge and agree as follows:

1. Secured Party hereby acknowledges and agrees that the Prepayment Amount has been repaid in full and that, pursuant to the terms of the Trademark Security Agreement, the first priority lien and continuing security interest that SPI BV granted to Secured Party, and all other security interests, liens or rights that Secured Party may hold, in, to and under the Trademark Collateral, including without limitation the Registered Marks, and all rights, title and interest therein and all renewals and extensions thereof, together with the goodwill of the business associated with and symbolized thereby, has been and hereby is unconditionally, irrevocably and absolutely terminated, released, extinguished and forever completely discharged. Secured Party confirms that the Trademark Collateral is and shall be absolutely freed and discharged of and from the security interest provided in the Trademark Security Agreement and under the Distribution Agreement.

2. Secured Party further acknowledges, agrees and warrants that this Termination and Release shall be binding upon Secured Party's parent company, subsidiaries and other related entities, including without limitation William Grant & Sons, Ltd. and William Grant & Sons Distillers Limited, and its and their respective successors, assigns and legal representatives.

3. Secured Party hereby authorizes SPI BV to record on its behalf, and hereby authorizes and requests that the Commissioner of the United States Patent and Trademark Office or his delegate to record, this Termination and Release against each of the Registered Marks.


4. Secured Party shall cooperate with SPI BV to effect the release of any financing statements that have been filed by, for the benefit of, or on behalf of Secured Party with respect to the Trademark Collateral and shall execute, deliver and perform such additional documents and any and all such acts as are reasonably requested by SPI BV in order to fully effect the intent of this Termination and Release. Secured Party represents and warrants that the only financing

statements filed pursuant to the Distribution Agreement and the Trademark Security Agreement was the UCC-1 financing statements filed in the District of Columbia, New York, and Virginia, copies of which are attached hereto as Exhibit A.

5. This Termination and Release (a) shall be governed by and construed in accordance with the laws of the State of New York, without giving effect to its principles or rules of conflict of laws to the extent such principles or rules would require or permit the application of the laws of another jurisdiction, (b) may be executed in one or more counterparts, each of which shall be an original, but all of which together shall constitute one instrument, (c) may be amended or supplemented only by written instrument signed by the parties hereto, and (d) shall not be construed as giving any person or entity, other than the parties hereto and their successors and permitted assigns, any right, remedy or claim under or in respect of this Termination and Release or any provision hereof. All capitalized terms used but not otherwise defined herein have the meanings given to them in to the Distribution Agreement or the Trademark Security Agreement as applicable.


