NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows.




2. **Authority.** Each of the undersigned represents and warrants that he or she is duly authorized to sign this Assignment on behalf of the party that he or she represents.
