Steinvooort, *notaris* (civil-law notary) in Amsterdam, on 14 June 2006, which legal merger became effective on 15 June 2006, and whereby Basell Holdings B.V. was the surviving company and Basell Technology Company B.V. was the disappearing company. As a consequence of this legal merger Basell Technology Company B.V. has ceased to exist and Basell Holdings B.V. has acquired all transferable assets and liabilities of Basell Technology Company B.V. which could be acquired by a third party by universal succession of title;
