ASSIGNMENT

WHEREAS, System Internals LLC, a Texas limited liability company, adopted and used in its business the trademark "SYSINTERNALS," which is registered in the United States Patent and Trademark Office under Registration No. 2444291 and which was issued April 17, 2001 (the "Trademark"); and

WHEREAS, Microsoft Corporation, a Washington corporation, having a place of business at One Microsoft Way, Redmond, Washington 98052-6399, was the sole shareholder of System Internals LLC; and

WHEREAS, System Internals LLC was dissolved on February 17, 2011, in the State of Texas and by operation of law, all of the assets and liabilities of System Internals LLC were transferred into the ownership of Microsoft Corporation as the sole shareholder; and

WHEREAS, System Internals LLC wishes to confirm, as a part of the complete winding up of its affairs, that Microsoft Corporation is the legal successor in interest to the Trademark and to arrange for the formal assignment of the Trademark to Microsoft Corporation.

Be it known that System Internals LLC, by these presents, does hereby acknowledge and confirm that as a result of its dissolution on February 17, 2011, that Microsoft Corporation currently holds, by operation of law, the entire right, title and interest in and to the Trademark and registration, and the goodwill of the business in connection with which the Trademark is used and all claims for damages by reason of past infringement of the Trademark and registration, and the right to sue for and collect such damages.
