RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

WHEREAS, pursuant to the security agreement recorded with the United States Patent and Trademark Office at Reel 016932, Frame 0626 (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement") between Polyflow, Inc. ("Seller") and Canam Group Inc. ("Canam"), Placements CMI Inc. ("Placements CMI"), as successor by assignment to Canam's interest under the Security Agreement, holds a continuing security interest in Seller's right, title and interest in and to the patents, patent applications, registered trademarks and common law trademarks set forth in Exhibit A hereto (collectively, the "Released Patents and Trademarks"); and

NOW, THEREFORE, for good and valuable consideration (including without limitation the benefits accruing to the Affiliate under the Purchase Agreement), the receipt and sufficiency of which are hereby acknowledged:

1. Placements CMI hereby releases and forever discharges all of the security interest, liens, encumbrances and other rights and interests in and to the Released Patents and Trademarks that it, Canam or any other person or entity has or may have pursuant to the Security Agreement or any other document executed in connection with the Security Agreement or otherwise.



3. Except to the extent that federal law preempts state law with respect to the matters covered hereby, this Release shall be governed by and construed in accordance with the laws of the State of Delaware without giving effect to the principles of conflicts of laws thereof.
