enforcement of any obligation of Trend Micro Braintree, Inc. arising from the merger, including the rights of any dissenting stockholders thereof, and Trend Micro Incorporated hereby irrevocably appoints the Secretary of State of the State of Delaware as its agent to accept service of process in any such suit or other proceedings and a copy of such process shall be mailed by the Secretary of State to Trend Micro Incorporated at the following address: 10101 N.
