A Stipulation having been entered into for Assignment of Remaining Estate Assets by and between JOHN M. CHASE, JR., as Successor Personal Representative under the Last Will and Testament of Martha Jean Steinberg, Deceased; ALAN A. MAY as Attorney for Diane Steinberg Lewis, daughter of the deceased; IRA S. AUSLANDER as Attorney for Sandra K. Steinberg and Trienere E. Steinberg, daughters of the deceased; and all of her heirs at law; and the Court being fully advised in the premises;

NOW, THEREFORE, IT IS ORDERED THAT the Estate's 10% membership in Partner's Detroit, LLC, is assigned in its entirety to the Queen's Blessings, LLC, a Limited Liability Company, wherein Diane Steinberg Lewis, Sandra K. Steinberg and Trienere E. Steinberg are members and Diane Steinberg Lewis is the manager.

IT IS FURTHER ORDERED THAT all of the right, title and interest of the decedent in six (6) trademarks and three (3) common law marks as set forth in Schedule A appended to this Order is assigned an undivided one-third (1/3) share each, as tenants in common, to Diane Steinberg Lewis, Sandra K. Steinberg and Trienere K. Steinberg.

IT IS FURTHER ORDERED THAT the Successor Personal Representative shall pay in equal one-third (1/3) shares to Diane Steinberg Lewis, Sandra K. Steinberg and Trienere K. Steinberg the entire balance of cash remaining in the Estate, being \$2,785.26 as of July 17, 2009, as set forth in the Bank of America statement for Account No. 0000 1504 8441 appended to the Stipulation, less the \$20.00 filing fee paid by the Successor Personal Representative regarding the Petition for Assignment of Remaining Estate Assets, as well as all filing fees and costs relating to the Stipulation entered into between the parties and this Order entered pursuant thereto.

IT IS FURTHER ORDERED THAT the requirement of John M. Chase, Jr., as Successor Personal Representative to file a Supplement to his Third and Final Account is waived.

IT IS FURTHER ORDERED THAT upon the entry of this Order pursuant to the Stipulation and delivery of the funds to which the three (3) daughters of the decedent are entitled, a Receipt from the Manager of the Queen's Blessings, LLC, for the ten (10%) percent membership in Partner's Detroit, LLC, and appropriate Receipts for the balance of the Estate assets from each of the three (3) daughters of the decedent, Diane Steinberg Lewis, Sandra K. Steinberg and Trienere K.

Steinberg, will be obtained by their respective attorneys and delivered to John M. Chase, Jr., as Successor Personal Representative for filing with the Wayne County Probate Court so that he may obtain his discharge and bring the Estate proceedings to a formal conclusion.




