WHEREAS, Merrill Lynch & Co., Inc. ("MLC") ("Assignor"), a Delaware corporation has adopted, used and owned the trademark CICERO (the "Mark"), which on November 6, 1990 was registered in the U.S.P.T.O., Registration No. 1621002; and

WHEREAS, Cicero Inc. (f/k/a Level 8, Inc.) ("Assignee"), a Delaware corporation with a principal address at 8000 Regency Parkway, Cary, N.C. 27511 wishes to confirm its acquisition of said Mark and the registration thereof; and

WHEREAS, MLC was the record owner of U.S. Reg. No. 1621002 for CICERO (the "Mark") according to the records of the Assignment Division of the United States Patent and Trademark Office as of January 3, 2002; and


WHEREAS, the parties desire to enter into a nunc pro tunc assignment to reflect that ownership of the Mark passed from MLC to Cicero effective as of January 3, 2002; and

NOW, therefore, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor agrees that Assignor hereby assigned unto Assignee nunc pro tunc effective as of January 3, 2002, all of Assignor's right, title and interest in and to the Mark, throughout the world, together with all the goodwill associated with the business connected with the use of, and symbolized by, such Mark.
