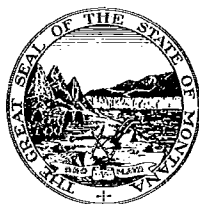

RESOLVED, that the change in the Company's name shall not provide for an exchange, reclassification or cancellation of any issued shares;




