ASSIGNMENT OF TRADEMARK  
OPTIXRX

This Assignment of Trademark ("Assignment") is made as of MAY 5, 2011 2011, by and between OptixRx, LLC, a Michigan limited liability company ("Assignor") and OptixRx, LLC, a New Mexico limited liability company ("Assignee").

For good and valuable consideration, the receipt and sufficiency of which is acknowledged, Assignor and Assignee want to assign the trademark OPTIXRX (including all stylized representations thereof, the "Mark"), as follows.

1. Assignment. Assignor assigns and transfers to Assignee all right, title and interest of Assignor in and to the Mark, together with: (i) all goodwill of the business symbolized by or associated with the Mark; (ii) Assignor's entire right, title, and interest in and to any and all current and future registrations of the Mark and applications to register the Mark, including but not limited to U.S. Serial No. 78698278; (iii) any and all common law rights to the Mark in the United States and any state thereof and in any country in the world; and (iv) any and all claims and demands Assignor may have either at law or in equity arising out of any past infringements.

2. No Retained Rights. Assignor will have no rights remaining in the Mark after the effective date of this Agreement. Assignor will not use and will not direct or allow any person or entity over which it has control to use the Mark or any confusingly similar mark or name.

3. Cooperation. Assignor agrees, upon the request of Assignee and for no additional consideration, to do all other acts, provide any evidence and execute all documents necessary or desirable to effect or evidence the transfer, assignment, recordation, application, registration, issuance, maintenance, renewal, establishment, and enforcement of the Mark.

4. No liabilities. Assignee will assume no liabilities or obligations of Assignor of any type or nature in connection with Assignor or the operation of its business or otherwise.

5. Counterpart Originals. This Agreement may be executed in counterpart, each of which will be deemed an original, but both of which together will constitute one and the same instrument.

6. Miscellaneous. This Agreement constitutes the entire agreement of Assignor and Assignee with respect to its subject matter, is binding upon Assignor and Assignee and their successors and assigns, and is governed by the laws of the United States and the State of New Mexico without regard to the choice of law principles thereof.
