WHEREAS, Assignee is desirous of acquiring the Trademark, and Assignor is willing to assign it to Assignee pursuant to the terms of this Assignment;


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follow:
