RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (the "Release"), is granted and conveyed as of this 5th day of May, 2011, by PHOENIX LIFE INSURANCE COMPANY (formerly Phoenix Home Life Mutual Insurance Company), a New York corporation, in its capacity as collateral agent ("Agent"), in favor of HAMPSHIRE DESIGNERS, INC., a Delaware corporation ("Obligor").

WITNESSETH:

WHEREAS, pursuant to that certain Trademark Collateral Assignment and Security Agreement, dated as of September 5, 2000, by and between Obligor and Agent (the "Security Agreement"), Obligor granted a continuing security interest in certain of its tangible and intangible personal property, including, but not limited to, the trademarks listed on the attached Schedule A and the federal registrations and applications therefor (collectively, the "Released Trademarks");

WHEREAS, the Security Agreement was filed on behalf of Agent in the United States Patent and Trademark Office, on September 15, 2000 at reel/frame 2148/0216, to evidence the security interest granted to Agent thereunder;

WHEREAS, Obligor has requested that Agent: (a) terminate and release the liens and interests of Agent in the Released Trademarks; and (b) execute evidence of such termination and release and deliver the same to Obligor for filing in the United States Patent and Trademark Office; and


WHEREAS, Obligor has satisfied and fulfilled all of its obligations to release the Agent's security interest in the Released Trademarks under the Security Agreement, and the parties seek to make a record of Agent's release and reassignment to Obligor of any and all of its security interests in the Released Trademarks.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Agent hereby releases, discharges, and relinquishes its security interest in the Released Trademarks. Agent specifically acknowledges that its security interest in the Released Trademarks is no longer in force.
