I'm writing today to request a change in the Registrant information with respect to Registration No. 3748352 for the trademark MUD LIFE. In support of my request, I represent and warrant as follows:

1. I caused my attorneys at Darby & Darby to file Serial No. 77631399 (the "Application") on December 11, 2008 to register the trademark MUD LIFE.
2. The Application identifies the Applicant as Mud Life Magazine, a Florida corporation. However, at the time of the filing of the Application, Mud Life Magazine was not in fact a corporation. Rather, Mud Life Magazine was a sole proprietorship owed by the undersigned under Florida law.
3. My attorneys at Darby & Darby should have listed Douglas A. Perera as the Applicant in the Application, but mistakenly identified the Applicant as Mud Life Magazine.
4. Subsequent to the filing of the Application and the issuance of Registration No. 3748352, I caused Mud Life Magazine, LLC to be formed. I'm the sole owner and member of Mud Life Magazine, LLC.
5. Mud Life Magazine, LLC is the successor in interest to my sole proprietorship that owned and operated Mud Life Magazine.
6. Registration No. 3748352 now is an asset of Mud Life Magazine, LLC and should be held in the name of Mud Life Magazine, LLC.

Accordingly, I hereby request that the Patent & Trademark Office change the Registrant of Registration No. 3748352 to Mud Life Magazine, LLC.
