2. Assignor warrants that it is the legal owner of all right, title, and interest in the Intellectual Property, that the Intellectual Property has not been otherwise previously pledged, assigned, or encumbered, and that this assignment does not infringe on the rights of another.

3. Assignor agrees to cooperate with Assignee and to execute and deliver all papers, instruments, and assignments as may be necessary to vest all right, title, and interest in and to the Intellectual Property, including, without limitation, recordation of the assignment in the United States Patent and Trademark Office.




