## NOTICE OF RELEASE OF SECURITY INTEREST

This Release of a Security Interest is effective as of May 10, 2011, by BANK OF AMERICA, N.A., formerly BankAmerica Business Credit, Inc., in its capacity as agent for various lenders ("Agent").
