GRANT OF SECURITY INTEREST
IN UNITED STATES TRADEMARKS

FOR GOOD AND VALUABLE CONSIDERATION, receipt and sufficiency of which are hereby acknowledged, 2283546 Ontario Inc., a corporation incorporated under the laws of the Province of Ontario with principal offices at 370 King Street West, Suite 435, Toronto, Ontario M5V 1J9 (the "Grantor"), hereby pledges and grants to The Bank of Nova Scotia, a bank to which the *Bank Act* (Canada) applies with offices at 40 King Street West, 62nd floor, Toronto, Ontario M5W 2X6 (the "Grantee"), a continuing security interest in all of the right, title and interest of such Grantor in, to and under (i) the United States trademarks, trademark registrations and trademark applications (the "Marks") set forth on Schedule A attached hereto, (ii) all proceeds and products of the Marks, (iii) the goodwill of the businesses with which the Marks are associated, and (iv) all causes of action, arising prior to or after the date hereof, and all damages and payments for past, present or future infringements of any of the Marks or unfair competition regarding the same (collectively, the "Mark Collateral").

THIS GRANT is made to secure the prompt and complete payment and performance when due of all the obligations of the Grantor, as further described in the General Security Agreement by the Grantor in favour of the Grantee, dated as of the date hereof (as amended, modified, restated and/or supplemented from time to time, the "Security Agreement"). Upon the payment in full of all obligations under or in connection with, and the termination of the Security Agreement, the Grantee shall, at the Grantor's sole expense, execute, acknowledge, and deliver to the Grantor an instrument in writing releasing the security interest in the Mark Collateral acquired under this Grant.




