

RELEASE OF TRADEMARK SECURITY INTERESTS dated as of April 26, 2011 (this "**Release**"), by CREDIT SUISSE AG, CAYMAN ISLANDS BRANCH (formerly known as Credit Suisse, Cayman Islands Branch) ("**Credit Suisse**"), as agent (in such capacity, the "**Agent**"). Capitalized terms used herein and not otherwise defined shall have the meanings assigned to such terms in the Credit Agreement or the Trademark Security Agreement, as applicable.

A. Reference is made to (i) the Loan and Security Agreement dated as of August 4, 2009 (as amended, supplemented or otherwise modified from time to time, the "**Credit Agreement**"), among Commercial Vehicle Group, Inc. (the "**Borrower**"), the lenders from time to time party thereto and Credit Suisse, as Agent, and (ii) the Trademark Security Agreement dated as of August 4, 2009, among the Borrower, the Subsidiaries of the Borrower party thereto and Credit Suisse, as Agent (the Trademark Security Agreement, together with the Credit Agreement, the "**Security Agreements**").

B. Pursuant to the Security Agreements, the Borrower and each Domestic Subsidiary (the "**Grantors**"), granted to the Agent, for the benefit of the Secured Parties, a security interest in all right, title or interest of the Grantors in the Collateral, including the trademarks of the Grantors set forth on Schedule I hereto (collectively, the "**Trademarks**"), which security interests were recorded with the United States Patent & Trademark Office on August 6, 2009 at Reel/Frame 04038/0678.

C. Pursuant to the Second Lien Termination and Release Agreement dated as of April 26, 2011, among the Borrower, the Administrative Agent and the Agent, the Agent has agreed to release any and all security interests it may have in the Collateral pursuant to the Security Agreements.

Accordingly, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent does hereby release, relinquish and discharge any and all security interests it has against the Collateral. The Agent hereby authorizes the Borrower to make filings with the United States Patent & Trademark Office and other necessary filings, at the expense of the Borrower, to evidence the release and termination of the Agent's security interests in the Collateral set forth in the Trademark Security Agreement.

THIS RELEASE SHALL BE GOVERNED BY AND CONSTRUED IN ACCORDANCE WITH THE LAWS OF THE STATE OF NEW YORK AND SHALL BE BINDING UPON THE AGENT'S REPRESENTATIVES, SUCCESSORS, ASSIGNS AND TRANSFEREES.
