TERMINATION AND RELEASE OF FIRST LIEN SECURITY INTEREST IN TRADEMARK RIGHTS

TERMINATION AND RELEASE effective as of April 20, 2011, from JPMORGAN CHASE BANK, N.A., as Collateral Agent (the "Agent") for certain banks and other financial institutions (the "Lenders"), to DELTA AIR LINES, INC. a Delaware corporation, COMAIR HOLDINGS, L.L.C., a Delaware limited liability company, and COMAIR, INC., an Ohio corporation (collectively, the "Grantors").

WITNESSETH:

WHEREAS, pursuant to the First Lien Security Agreement, dated April 30, 2007, made by the Grantors in favor of the Agent (together with all amendments and modifications, if any, from time to time thereafter made thereto, the "First Lien Security Agreement"), a security interest (the "Security Interest") was granted by the Grantors to the Agent in certain collateral, including the Trademark Collateral (as hereinafter defined);

WHEREAS, pursuant to the First Lien Grant of Security Interest in Trademark Rights effective as of May 8, 2007, among the Agent and the Grantors (the "Security Agreement"), the Grantors, by reference to the First Lien Security Agreement, reaffirmed their intent to grant a Security Interest to the Agent specifically in certain Trademark Collateral;

WHEREAS, the Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on May 18, 2007 at Reel 003545 and Frame 0439;

WHEREAS, the Agent now desires to terminate and release the entirety of its Security Interest in the Trademark Collateral:

NOW, THEREFORE, for good and valuable consideration including the satisfaction of all obligations, indebtedness and liabilities secured by the Trademark Collateral pursuant to the First Lien Security Agreement, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Agent hereby states as follows:

- 1. <u>Definitions</u>: The term "Trademark Collateral," as used herein, shall mean all of the Grantors' right, title and interest of every kind and nature as of the date hereof in the Trademarks (including, without limitation, those items listed on Schedule A hereto). The term "Trademarks" shall have the meaning provided by reference in the First Lien Security Agreement.
- 2. <u>Release of Security Interest</u>: The Agent hereby terminates, releases and discharges its Security Interest in the Trademark Collateral, and any right, title or interest of the Agent in such Trademark Collateral shall hereby cease and become void.
- 3. <u>Further Assurances</u>: The Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the Security Interest contemplated hereby.
