CERTIFICATE OF AMENDMENT  
OF THE  
CERTIFICATE OF INCORPORATION  
OF  
ALCAN COMPOSITES USA INC.

1. ALCAN COMPOSITES USA INC., (the "Corporation"), is a corporation which was organized under and pursuant to the laws of Missouri, on October 10, 1986 as Alucobond Technologies Corporation;
2. The Corporation was subsequently known as Alusuisse Composites, Inc., and is now known as Alcan Composites USA Inc.;
3. The Board of Directors of the Corporation, acting by unanimous written consent, dated February 19, 2010 adopted resolutions recommending an amendment to the Corporation's Certificate of Incorporation to change the name of the Corporation as follows:

RESOLVED, that the first paragraph of the Corporation's Certificate of Incorporation shall be amended to read as follows:

FIRST: The name of the Corporation shall be:

3A Composites USA Inc.

4. The number of common shares entitled to vote on the Amendment was 100.
5. The owner of the 100 common shares entitled to vote consented to the Amendment by Unanimous Written Consent dated February 19, 2010.
