The Assignor further authorizes the Commissioner of Patents and Trademarks of the United States, whose duty it is to record trademark registrations, applications and title thereto, to record the Trademarks and title thereto as the property of the Assignee, its legal representatives, successors and assigns in accordance with the terms of this Assignment of Trademarks.

The Assignor further agrees to execute such additional documents as may be required in the United States to record the Assignee as the owner of the trademarks and registrations and applications herein assigned.
