**TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT**  
dated as of May 7, 2011, by BANK OF AMERICA, N.A., a national banking association, as successor by merger to LaSalle Business Credit, LLC (the "Secured Party").


**WHEREAS**, Merge Left, Inc., a Nevada corporation (the "Grantor"), and the Secured Party entered into a Trademark Security Agreement, dated as of April 22, 2008 (the "Security Agreement"), which Security Agreement was recorded with the United States Patent and Trademark Office. Issued Trademarks were recorded on April 24, 2008, at Reel 3766, Frame 0115, for the purpose of collateral security for all indebtedness and obligations of the Grantor to the Secured Party arising under a certain Loan Agreement (as defined in the Security Agreement);

**WHEREAS**, pursuant to the Loan Agreement and the Security Agreement, the Grantor pledged and assigned to the Secured Party, and granted the Secured Party a security interest with power of sale in, the Trademarks (as defined in the Security Agreement), including, without limitation, the marks listed on Exhibit A hereto. The Trademarks are referred to herein collectively as the "Intellectual Property"; and

**WHEREAS**, the Secured Party has agreed to terminate and release its security interest in the Intellectual Property as herein provided;

**NOW, THEREFORE**, for valuable consideration the Secured Party hereby terminates and releases its security interest in the Intellectual Property, including, without limitation, the Trademarks listed on Exhibit A hereto, and the Secured Party hereby assigns and transfers to the Grantor, without representation, warranty or recourse, all of the Secured Party's right, title and interest in and to such Intellectual Property, effective as of the date set forth above.

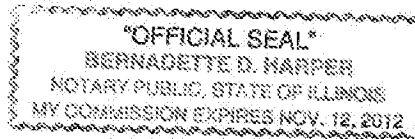
