1. The name of the corporation is MyTalk Social Networks, Inc. formerly known as the old name MyTalk Inc.

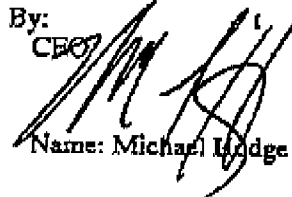
2. The Registered Office of the corporation in the State of Delaware is located at 9 East Lockerman Street, Suite 3 A
