## **RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This RELEASE OF SECURITY INTEREST IN TRADEMARKS is given as of this 18 day of May, 2011, by The CIT Group/Business Credit, Inc. ("Assignor"), as successor to The CIT Group/Credit Finance, Inc., in its capacity as Assignor in favor of Coleman Natural Products, Inc., a Delaware corporation ("Assignee").

- (b) the goodwill of the Assignee's business connected with and symbolized by the Trademarks (collectively, the "Collateral");

**WHEREAS**, Assignor desires to release its security interest in the Collateral.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby releases its security interest and lien in the Collateral and reassigns any and all interest that it may have therein to Assignee.

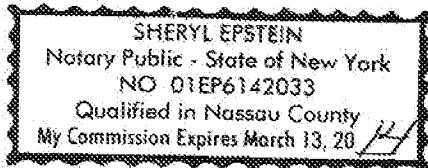
