WHEREAS, Eons is the owner of the following trademark (the "Trademark") now registered in the United States Patent and Trademark Office:



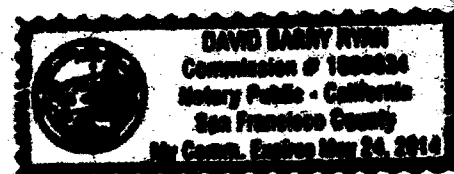
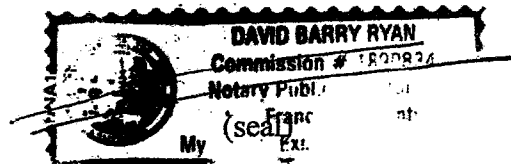
