**RELEASE OF TRADEMARK SECURITY AGREEMENT**

This Release of Trademark Security Agreement ("Release") is made this 19th day of May, 2011, by Wells Fargo Bank, National Association, in its capacity as administrative agent (the "Administrative Agent"), under that certain Second Amended and Restated Credit Agreement dated March 3, 2011 (the "Credit Agreement"), among the Administrative Agent, various lenders, and Dollar Financial Group, Inc. ("Debtor") and various affiliates of Debtor.

WHEREAS, reference is made to a certain Amended and Restated Trademark Security Agreement dated March 3, 2011 (the "Security Agreement") by Debtor in favor of Administrative Agent, recorded, among other places, with the United States Patent and Trademark Office on March 8, 2011 at Reel/Frame: 004492/0972;

WHEREAS, in connection with the Security Agreement, Debtor granted to Administrative Agent, for the benefit of the Secured Parties (as defined in the Security Agreement), a security interest in all of its Trademark Collateral (as defined in the Security Agreement), including, without limitation, the trademark listed below (the "Released Trademark"):

WHEREAS, Administrative Agent has the requisite power and authority to release and discharge its security interest in and to the Released Trademark on behalf of each Secured Party; and



NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and intending to be legally bound hereby, Administrative Agent hereby releases and remits to Debtor, on behalf of each Secured Party, any and all right, title and interest in and to its security interest in and to the Released Trademark, and reassigns, on behalf of each Secured Party, any and all interest it may have in such Released Trademark to Debtor. The Administrative Agent hereby authorizes the Debtor or Debtor's authorized representative to record this Release with the United States Patent and Trademark Office.
