TRADEMARK RELEASE

TRADEMARK RELEASE, effective as of this 23rd day of May, 2011, given by Deutsche Bank Trust Company Americas, as Security Agent (the "Agent") with principal offices at 60 Wall Street, New York, NY 10005, to Snow Ball Foods, LLC, a Delaware limited liability company (the "Grantor"), with principal offices at 1767 Denver West Marriott Road, Suite 200, Golden, Colorado 80401, as follows:
