RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS RELEASE dated as of May 19, 2011 (this "Release") is made by U.S. Bank National Association (as successor to U.S. Bank of Nevada), a national banking association, acting in its capacity as secured party (in such capacity, the "Agent Bank") under that certain Trademark Security Agreement, dated as of December 6, 1996 and recorded in the records of the United States Patent and Trademark Office (as amended, supplemented or modified and in effect from time to time, the "Security Agreement"), among Gemini, Inc., a Nevada corporation and International Marco Polo's Services, Inc., a Nevada corporation (the "Debtors") and the Agent Bank.

WITNESSETH:

WHEREAS, pursuant to the Security Agreement, which was recorded in the records of the United States Patent and Trademark Office, at reel/frame, 1540/0587, on December 27, 1996, the Debtors granted to the Agent Bank a continuing security interest in all of the Debtors' Intellectual Property Collateral (as defined in the Security Agreement) including those set forth on the attached Schedule A;

WHEREAS, the Agent Bank wishes to: (i) terminate the Security Agreement against the Intellectual Property Collateral including those identified in the attached Schedule A hereto, recorded with the United States Patent and Trademark Office; (ii) release all of its security interest covering the Intellectual Property Collateral including those listed in the attached Schedule A; (iii) restore all right, title and interest in and to the Intellectual Property Collateral including those listed in the attached Schedule A, to Debtors; and (iv) to dissolve any and all liens and encumbrances respecting the Intellectual Property Collateral including those listed in the attached Schedule A.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Agent Bank does hereby release its security interest in the Intellectual Property Collateral including those set forth on the attached Schedule A hereto, and discharges, quit claims and relinquishes unto the Debtors, in each case without recourse and without any representation or warranty, any and all rights, title and interest it has in and the security interest granted to Agent Bank in the Intellectual Property Collateral including those listed in the attached Schedule A.
