RELEASE OF GRANT OF TRADEMARK SECURITY INTEREST

THIS RELEASE dated as of May 9, 2011 (this "Release") is made by Canadian Imperial Bank of Commerce, as Administrative Agent, a Canadian Chartered Bank, acting in its capacity as secured party (in such capacity, the "Secured Party") under that certain Grant of Trademark Security Interest, dated as of June 29, 2001 and recorded in the records of the United States Patent and Trademark Office (as amended, supplemented or modified and in effect from time to time, the "Security Agreement"), among Isle of Capri Casinos, Inc., a Delaware corporation (the "Grantor") and the Secured Party.

W I T N E S S E T H:

WHEREAS, pursuant to the Security Agreement, which was recorded in the records of the United States Patent and Trademark Office, at reel/frame, 002330/0221 on July 20, 2001, the Grantor granted to the Secured Party a continuing security interest in all of the Grantor's Trademark Collateral (as defined in the Security Agreement) including those set forth on the attached Schedule A;

WHEREAS, the Secured Party wishes to: (i) terminate the Security Agreement against the Trademark Collateral including those identified in the attached Schedule A hereto, recorded with the United States Patent and Trademark Office; (ii) release all of its security interest covering the Trademark Collateral including those listed in the attached Schedule A; (iii) restore all right, title and interest in and to the Trademark Collateral including those listed in the attached Schedule A, to Grantor; and (iv) to dissolve any and all liens and encumbrances respecting the Trademark Collateral including those listed in the attached Schedule A.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Secured Party does hereby release its security interest in the Trademark

Collateral including those set forth on the attached Schedule A hereto, and discharges, quit claims and relinquishes unto the Grantor, in each case without recourse and without any representation or warranty, any and all rights, title and interest it has in and the security interest granted to Secured Party in the Trademark Collateral including those listed in the attached Schedule A.
