Re: Release and Termination of Liens

Ladies and Gentlemen:

Reference is hereby made to the Third Amended and Restated Credit Agreement, dated as of August 9, 2010 (as amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement"; capitalized terms used herein but not otherwise defined shall have the meanings ascribed to such terms in the Credit Agreement), by and among BLOUNT, INC., a Delaware corporation ("Blount, Inc."), GEAR PRODUCTS, INC., an Oklahoma corporation ("Gear"), OMARK PROPERTIES, INC., an Oregon corporation ("Omark"), WINDSOR FORESTRY TOOLS LLC, a Tennessee limited liability company ("Windsor") (Gear, Omark, Windsor and Blount, Inc. are sometimes referred to herein collectively as "Borrowers" and individually as "Borrower"); the other Credit Parties signatory thereto; the other lenders party thereto (the "Lenders"); and GENERAL ELECTRIC CAPITAL CORPORATION, a Delaware corporation, in its capacity as agent for the Lenders ("Agent").

1. Release. Agent, on behalf of itself and the Lenders, hereby releases, terminates and discharges, without recourse and without any representation or warranty of any kind, express or implied, (a) all security interests and liens of any nature whatsoever on the assets and property of Gear granted pursuant to the Credit Agreement and the other Loan Documents and (b) Gear from any further obligation or liability under the Credit Agreement and the other Loan Documents, including, without limitation, the repayment of all or any portion of the Obligations. Nothing contained herein shall be deemed a release or termination by Agent of any security interests in and liens on any assets of any Credit Party other than Gear or a discharge of liability of any Credit Party with respect to the repayment of the Obligations, all of which shall continue in full force and effect. Except as specifically set forth herein, nothing contained herein shall be construed in any manner to constitute a waiver, release or termination or to otherwise limit or impair any of the obligations or indebtedness of any Credit Party or any other person or entity to Agent and the Lenders, or any duties, obligations or responsibilities of the Credit Party or any other person or entity to Agent and the Lenders.

2. Further Assurances. Agent hereby agrees that it shall file, at the Borrowers' sole cost and expense, or authorizes Borrowers to file, the UCC financing termination statements and the partial release of mortgage, in each case, attached hereto as Exhibit A. Agent shall, at the reasonable request of Borrowers, execute and/or deliver such instruments and other writings as may be necessary to effect or evidence the termination of the liens of Agent on Gear, but without

representation, warranty or recourse to Agent or the Lenders and at the sole cost and expense of Borrowers.



This Release and Termination of Liens may be executed in any number of counterparts and by different parties in separate counterparts, each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement. Signature pages may be detached from multiple separate counterparts and attached to a single counterpart. Delivery of an executed signature page of this Release and Termination of Liens by facsimile transmission or other electronic transmission shall be as effective as delivery of a manually executed counterpart hereof.

4. Miscellaneous. This Release and Termination of Liens shall be governed by and interpreted and determined in accordance with the laws of the State of New York.
