CORRECTIVE ASSIGNMENT

This Corrective Assignment is being filed to inform the USPTO Assignments Division that the Change of Name document filed and recorded on November 25, 2008 at Reel/Frame: 3893/0499 was improperly recorded against the above-referenced trademark registration. The registrant, LF, LLC, therefore respectfully requests that the chain of title be corrected to reflect the true owner of the trademark registration to be LF, LLC.

As set forth in the Assignment Abstract of Title, the ownership of this registration was transferred from the original applicant, Normarc Inc. (who changed its name to Barenbrug USA Inc. through a Change of Name recordation on October 26, 1998 at Reel 1806/Frame 0576) to Costa Nursery Farms LLC on February 13, 2008 at Reel 3718/Frame 0754. An Assignment from Costa Nursery Farms LLC to Lowe's Companies, Inc. was thereafter filed and recorded with the USPTO Assignments Division on May 22, 2008 at Reel 3781/Frame 0725. Lowe's Companies Inc. assigned the trademark registration to Lowe's HIW, Inc., an assignment for which was recorded on May 23, 2008 at Reel 3782/Frame 0103. Finally, the registration was transferred from Lowe's HIW, Inc. to LF, LLC. Attached hereto as Exhibit A is a copy of the Notice of Recordation issued by the USPTO Assignment Division on May 27, 2008, confirming the recordation of the Assignment from Lowe's HIW, Inc. to LF, LLC and recorded at Reel 3782/Frame 0891 on May 27, 2008.

A Change of Name document from Costa Nursery Farms LLC to Costa Farms LLC was erroneously recorded with the USPTO Assignments Division on November 25, 2008 at Reel 38893/Frame 0499. LF, LLC has been and continues to be the owner of the registration at issue and has not assigned its rights to the registration.

In light of the above, Registrant requests that the chain of title be corrected to reflect LF, LLC as the true owner of the registration.
