**PARTIAL RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**  
**Trump Marina Associates, LLC**

THIS PARTIAL RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY ("Partial Release") is made as of May 24, 2011, by Beal Bank, SSB, as Administrative Agent and Collateral Agent (collectively in such capacity, the "Agent"), in connection with that certain Amended and Restated Credit Agreement, dated July 16, 2010 (as it may have been amended, restated, supplemented or modified from time to time, the "Credit Agreement") by and among Trump Entertainment Resorts Holdings, L.P. ("Borrower"), Trump Entertainment Resorts, Inc. ("Resorts"), TERH LP, Inc. ("TERH"), Trump Marina Associates, LLC ("Marina"), Trump Plaza Associates, LLC ("Plaza"), Trump Taj Mahal Associates, LLC ("Taj"), and Trump Entertainment Resorts Development Company, LLC ("Resorts Development") (each a "Guarantor" and each a "Loan Party" and collectively with the Borrower the "Loan Parties"), the Lenders named therein ("Lenders") and Agent. (Capitalized terms used herein and not defined herein shall have the same meaning as in the Credit Agreement).

WHEREAS, pursuant to the Credit Agreement and that certain Amended and Restated Intellectual Property Security Agreement, dated as of July 16, 2010 ("IP Security Agreement"), each of Borrower and Guarantors (collectively, the "Grantors"), granted a security interest in their trademarks, patents and copyrights and other intellectual property to the Agent as security for their Obligations under the Credit Agreement and other Loan Documents and all rights, title and interest in and to any such property, which IP Security Agreement was recorded in the U.S. Patent and Trademark Office on July 29, 2010 at Reel 4250, Frame 0079 and on July 21, 2010 at Reel 4254, Frame 0897; and


WHEREAS, Marina has requested that Agent terminate, release and discharge the security interests and Liens granted to Agent in those certain trademarks of Marina described on Exhibit A hereto ("Marina IP"), and has requested that the Agent issue this Partial Release to evidence Agent's release of such security interests and Liens against the Marina IP with the U.S. Patent and Trademark Office.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged by the parties, Agent does hereby terminate, release and discharge any security interest and Lien in the Marina IP previously granted to it by the Loan Parties pursuant to the IP Security Agreement, the Credit Agreement, or any other Loan Document, provided, however, that (i) the IP Security Agreement shall remain in full force and effect in respect to all other Intellectual Property Collateral except for the Marina IP and (ii) notwithstanding this Partial Release, the Agent shall retain its Lien and security interest on all Intellectual Property in which any Loan Party has any right, title or interest except for the Marina IP.
