TRADEMARK RELEASE

THIS TRADEMARK RELEASE (this "Release") is given as of this 25th day of May, 2011 by Wells Fargo Bank, National Association (as successor-in-interest to Wachovia Capital Finance Corporation (Central)), as lender (the "Grantee") to Eschelon Telecom, Inc., a Delaware corporation ("Grantor") as follows:

WHEREAS, the Grantor entered into a Trademark Collateral Assignment and Security Agreement, dated as of June 5, 2006 (as amended, supplemented and otherwise in effect as of the date hereof, the "Trademark Security Agreement"), in favor of Wachovia Capital Finance Corporation (Central) ("WCFC") under the Credit Agreement referred to herein, pursuant to which the Grantor granted to WCFC a security interest in certain intellectual property, including the U.S. trademarks listed on Schedule 1 attached hereto (the "Released Trademarks"), as collateral security for the payment and performance of certain obligations set forth in the Loan and Security Agreement, dated as of June 5, 2007, among the Grantor, WCFC, and certain other parties thereto (as amended, modified, restated, amended and restated and supplemented, the "Credit Agreement");

WHEREAS, the Trademark Security Agreement was recorded in the United States Patent and Trademark Office on June 20, 2007 at Reels/Frames 3564/0299 and 3564/0318.

WHEREAS, On December 31, 2008 Wells Fargo Bank, National Association purchased WCFC and assumed all of WCFC's rights, title and interest in and under the Credit Agreement, Trademark Security Agreement and the Released Trademarks;


WHEREAS, the Grantee has agreed to release its existing security interest in the Released Trademarks.

The Grantee hereby unconditionally, irrevocably and absolutely releases, terminates, extinguishes and forever discharges any and all of its rights, title to, and interest in the Released Trademarks. This Release shall be binding upon Grantee's legal representatives, assigns and successors. The parties hereto authorize and request the Director of Patents and Trademarks of the United States of America to record this Release against the Released Trademarks.
