RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL

THIS RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL (this "Release") is made as of May 24, 2011 (the "Effective Date") by **HBK INVESTMENTS L.P.**, a Delaware limited partnership, in its capacity as Agent for the Lender Group (together with its successors and assigns in such capacity, "Grantee"), in favor of the grantors listed on the signature pages to the Trademark Security Agreement (as such term is defined below) (collectively, "Grantor").

WHEREAS, reference is made to that certain Credit Agreement, dated as of November 7, 2006 (as amended, restated, supplemented, or otherwise modified from time to time, the "Credit Agreement"), by and among, the lenders identified on the signature pages thereof (such lenders, together with their respective successors and permitted assigns, are referred to hereinafter each individually as a "Lender" and collectively as the "Lenders"), Grantee, **CHUY'S OPCO, INC.**, a Delaware corporation ("Opco"), each of Opco's Subsidiaries identified on the signature pages thereof (such Subsidiaries, together with Opco, are referred to hereinafter each individually as a "Borrower", and individually and collectively, jointly and severally, as the "Borrowers"), and **CHUY'S HOLDINGS, INC.**, a Delaware corporation;

WHEREAS, pursuant to the terms and conditions of that certain Trademark Security Agreement, dated as of November 7, 2006 (as amended, restated, supplemented or otherwise modified from time to time, the "Trademark Security Agreement"), by and among Grantor and Grantee, and certain other Loan Documents, Grantor assigned, transferred and conveyed to Grantee, and granted to Grantee, a security interest in, all of Grantor's right, title and interest in and to the Trademark Collateral (as such term is defined in the Trademark Security Agreement);

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on November 10, 2006 at Reel 003426, Frame 0130; and

WHEREAS, Grantee has consented to the release of its Lien on the Trademark Collateral, including, without limitation, the trademark registrations and applications listed on Schedule I hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby covenants and agrees as follows:

1. All capitalized terms used but not otherwise defined herein shall have the meanings given to them in the Credit Agreement.

2. Grantee's Lien in the Trademark Collateral granted pursuant to any Loan Document is hereby terminated and released.

3. To the extent Grantee retains any interest in the Trademark Collateral, Grantee hereby assigns, transfers and conveys to Grantor, all of Grantee's right, title and interest, now owned or hereinafter acquired, that it may have whether by assignment or otherwise, in and to the Trademark Collateral.

4. Grantee hereby agrees to execute, acknowledge and deliver all such further instruments and to take all such further actions as may be reasonably requested or are required in order to more fully and effectively carry out the purposes of this Release at Grantor's sole cost and expense.


