## Execution Version

This Amended and Restated Trademark Security Agreement is subject to the terms and provisions of the Intercreditor and Subordination Agreement executed by SUN SCOOTER STORE FINANCE, LLC, as agent and lender, SUN CAPITAL PARTNERS MANAGEMENT V, LLC, CIT HEALTHCARE LLC and CRYSTAL FINANCIAL LLC dated as of May 17, 2011 (as amended, restated, supplemented or otherwise modified from time to time) and each holder of this Amended and Restated Trademark Security Agreement, by its acceptance hereof, shall be bound by the provisions of the Intercreditor and Subordination Agreement.

AMENDED AND RESTATED TRADEMARK SECURITY AGREEMENT

This Amended and Restated Trademark Security Agreement (this "Trademark Security Agreement") is made as of May 17, 2011, by the Grantors listed on the signature pages hereof (each a "Grantor" and collectively, the "Grantors"), in favor of Sun Scooter Store Finance LLC, a Delaware limited liability company, as Agent for itself and certain other lenders (together with its successors and assigns, "Agent").

WITNESSETH:

**WHEREAS**, pursuant to that certain Amended and Restated Senior Subordinated Term Loan and Security Agreement dated as of the date hereof (as the same may be further amended, restated, supplemented or otherwise modified from time to time, including all exhibits and schedules thereto, the "Credit Agreement") among the Grantors, certain of their affiliates, Agent and the Lenders party thereto, Agent and the Lenders agreed to make certain financial accommodations available to the Grantors and their affiliates from time to time pursuant to the terms and conditions of the Credit Agreement;

**WHEREAS**, pursuant to the Credit Agreement, the Grantors are required to execute and deliver to Agent for the benefit of the Lenders this Trademark Security Agreement.

**NOW, THEREFORE**, in consideration of the premises and mutual covenants herein contained and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, each Grantor hereby agrees as follows:

1. DEFINED TERMS. All capitalized terms used but not otherwise defined herein have the meanings given to them in the Credit Agreement.

2. GRANT OF SECURITY INTEREST IN TRADEMARK COLLATERAL. Each Grantor hereby grants to Agent, for the benefit of the Lenders, a continuing security interest in all of such Grantor's right, title and interest in, to and under the following, whether presently existing or hereafter created or acquired (collectively, the "Trademark Collateral"):

(a) all of such Grantor's trademarks, trademark applications, service marks, trade names and associated goodwill (collectively, "Trademarks"), and licenses granted by Grantor for any of the foregoing ("Licenses"), including those U.S. trademarks and U.S. trademark applications referred to on Schedule J hereto; and

(b) all products and proceeds of the foregoing, including any claim by such Grantor against third parties for past, present or future infringement or dilution of any Trademark or any Trademark licensed under any License.

3. SECURITY FOR OBLIGATIONS. This Trademark Security Agreement and the security interest created hereby secure the payment and performance of all of the Obligations, whether now existing or arising hereafter. Without limiting the generality of the foregoing, this Trademark Security Agreement secures the payment of all amounts that constitute part of the Obligations and would be owed by any Grantor to Agent and the Lenders, whether or not they are unenforceable or not allowable due to the existence of an insolvency proceeding involving any Grantor.

4. CREDIT AGREEMENT. The security interests granted pursuant to this Trademark Security Agreement are granted in conjunction with the security interests granted to Agent, for the benefit of the Lenders, pursuant to the Credit Agreement. Each Grantor hereby acknowledges and affirms that the rights and remedies of Agent with respect to the security interest in the Trademark Collateral made and granted hereby are more fully set forth in the Credit Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein.

5. AUTHORIZATION TO SUPPLEMENT. If any Grantor shall obtain rights to any new Trademarks or Licenses for Trademarks, this Trademark Security Agreement shall automatically apply thereto. Each Grantor shall give notice in writing to Agent within thirty (30) days after the end of each fiscal quarter with respect to any new Trademarks for which applications have been filed with the United States Patent and Trademark Office or Licenses for Trademarks from such fiscal quarter. Without limiting any Grantor's obligations under this Section 5, each Grantor hereby authorizes Agent unilaterally to modify this Trademark Security Agreement by amending Schedule I to include any such new U.S. Trademarks or Licenses for Trademarks of such Grantor. Notwithstanding the foregoing, no failure to so modify this Trademark Security Agreement or amend Schedule I shall in any way affect, invalidate or detract from Agent's continuing security interest in all Trademark Collateral, whether or not listed on Schedule I.

6. COUNTERPARTS. This Trademark Security Agreement may be executed in any number of counterparts, each of which shall be deemed to be an original, but all such separate counterparts shall together constitute but one and the same instrument. In proving this Trademark Security Agreement or any other Loan Document in any judicial proceedings, it shall not be necessary to produce or account for more than one such counterpart signed by the party against whom such enforcement is sought. Any signatures delivered by a party by facsimile transmission or by e-mail transmission shall be deemed an original signature hereto.

7. CONSTRUCTION. Unless the context of this Trademark Security Agreement or any other Loan Document clearly requires otherwise, references to the plural include the singular, references to the singular include the plural, the terms "includes" and "including" are not limiting, and the term "or" has, except where otherwise indicated, the inclusive meaning represented by the phrase "and/or." The words "hereof," "herein," "hereby," "hereunder," and similar terms in this Trademark Security Agreement or any other Loan Document refer to this




