**TERMINATION AND RELEASE OF  
TRADEMARK SECURITY AGREEMENT**

This TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT (the "Termination and Release") made as of the 23<sup>rd</sup> day of April, 2011, by UBS AG, STAMFORD BRANCH, in its capacity as Tranche A Administrative Agent pursuant to the Credit Agreement (as defined below) (in such capacity, the "Tranche A Administrative Agent") in favor of HABAND COMPANY LLC, JOHNNY APPLESEED'S, INC., NORM THOMPSON OUTFITTERS, INC., DRAPER'S & DAMON'S LLC, BLAIR LLC, LINEN SOURCE ACQUISITION LLC, ARIZONA MAIL ORDER COMPANY, INC., BEDFORD FAIR APPAREL, INC., LM&B CATALOG, INC., MONTEREY BAY CLOTHING COMPANY, INC., GOLD VIOLIN LLC, BLAIR HOLDINGS, INC. and WINTERSILKS, LLC (each, individually a "Pledgor" and collectively, the "Pledgors"). Capitalized terms not otherwise defined herein, shall have the meanings ascribed to them in the Credit Agreement and the Loan Documents.

**WITNESSETH:**

WHEREAS, pursuant to that certain (A) Senior Secured and Superpriority Debtor-In-Possession Credit Agreement dated as of January 20, 2011 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "Credit Agreement") among JAI and the other entities listed as Borrowers on the signature pages thereto, Appleseed's Intermediate Holdings LLC, a Delaware limited liability company ("Holdings"), the Subsidiary Guarantors (such term and each other capitalized term used but not defined herein having the meaning given it in Article I of the Credit Agreement), the Lenders, UBS SECURITIES LLC, as sole lead arranger and sole bookrunner (in such capacity, the "Arranger"), UBS LOAN FINANCE LLC, as swingline lender (in such capacity, "Swingline Lender"), Tranche A Administrative Agent, UBS AG, STAMFORD BRANCH, as issuing bank (in such capacity, "Issuing Bank"), and as co-collateral agent (in such capacity, a "Co-Collateral Agent"), ABLECO FINANCE LLC, as administrative agent for the Tranche B Lenders (in such capacity, "Tranche B Administrative Agent"), WELLS FARGO BANK, NATIONAL ASSOCIATION, as co-collateral agent (in such capacity, a "Co-Collateral Agent") and as co-documentation agent, ALLY COMMERCIAL FINANCE LLC, as co-documentation agent and AMERICAN CAPITAL LTD., as disbursement agent; (B) SECURITY AGREEMENT dated as of January 20, 2011 (as amended, amended and restated, supplemented or otherwise modified from time to time in accordance with the provisions hereof, the "Security Agreement") made by the Borrowers and Guarantors, as pledgors in favor of Tranche A Administrative Agent, pursuant to which the Pledgors were required to execute and deliver the Trademark Security Agreement (as defined below), made by the Pledgors in favor of the Tranche A Administrative Agent; and (C) TRADEMARK SECURITY AGREEMENT, dated as of January 20, 2011, by the Pledgors in favor of the Tranche A Administrative Agent (the "Trademark Security Agreement"), each Pledgor granted to the Tranche A Administrative Agent, for the benefit of the Secured Parties, a lien on and security interest in and to all of its right, title and interest under certain Pledged Collateral (as defined in the Security Agreement) of such Pledgor including (a) Trademarks of such Pledgor listed on Schedule I attached to the Trademark Security Agreement; (b) all Goodwill associated with such Trademarks; and (c) all Proceeds (as defined in the Security Agreement) of any and all

of the Trademarks listed on Schedule I to the Trademark Security Agreement (collectively, the "Trademark Collateral");

**WHEREAS**, the Trademark Security Agreement was recorded with the U.S. Patent and Trademark Office at Reel 025725, Frame 0685 on February 1, 2011;

**NOW, THEREFORE**, in consideration of the premises and for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

1. The Tranche A Administrative Agent, for the benefit of the Secured Parties, does hereby release and terminate all collateral pledges, grants, assignments, and liens and security interests in the pledged Trademark Collateral, including the Trademarks listed on Schedule I attached hereto.

2. The Tranche A Administrative Agent hereby agrees, at the expense of the Borrowers, to take any reasonable actions and to execute, acknowledge, procure and deliver any further documents necessary or reasonably requested by the Borrowers to effectuate, record or evidence the release of the Tranche A Administrative Agent's security interest in the Trademark Collateral.

3. The Tranche A Administrative Agent authorizes the Pledgors to request that the United States Patent and Trademark Office record this Termination and Release against the Trademark Collateral.


4. This Termination and Release shall be governed by the law of the State of New York.


