RELEASE OF SECOND LIEN TRADEMARK SECURITY AGREEMENT

THIS RELEASE OF SECOND LIEN TRADEMARK SECURITY AGREEMENT (this "Release") is made as of May 24, 2011 (the "Effective Date") by Bank of America, N.A., as collateral agent (in such capacity, the "Agent") for the benefit of Asurion, LLC (the "Borrower"), and Warranty Corporation of America (together with the Borrower, the "Grantor").

WHEREAS, pursuant to the terms and conditions of that certain Second Lien Guarantee and Collateral Agreement, dated as of July 3, 2007, between the Grantor and the Agent and the Second Lien Trademark Security Agreement between the Borrower and the Agent dated as of July 3, 2007 (the "Security Agreement"), the Grantor pledged, assigned and granted to the Agent a continuing security interest in all of its right, title and interest in and to certain collateral including, without limitation, the trademark registrations and applications set forth on Schedule I hereto along with the goodwill associated therewith (collectively, the "Trademarks");

WHEREAS, the Security Agreement was recorded with the Trademark Division of the U.S. Patent & Trademark Office on July 11, 2007, at Reel 003578 and Frame 0605;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby terminates the Security Agreement and the Supplemental Security Agreement, and hereby terminates, cancels, re-pledges, re-assigns and releases any and all security interests it has against the Trademarks.

If and to the extent the Agent has acquired any right, title or interest to any of the Trademarks, it hereby assigns and transfers such rights, title or interest to their respective Grantors.

The Agent shall take all further actions, and provide to the Grantors and their successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantors to more fully and effectively effectuate the purposes of this Release.
