Release of Lien on Trademarks

This Release of Lien on Trademarks (the "Release"), dated as of 05/23/2011, 2011 is made by the lenders listed on the signature pages hereto (collectively, the "Secured Parties") in favor of Tubular Textile Machinery Inc., a Delaware corporation (the "Debtor"), located at 113 Woodside Drive, Lexington, North Carolina, 27292.
