## **RELEASE OF INTELLECTUAL PROPERTY SECURITY INTEREST**

**THIS RELEASE OF INTELLECTUAL PROPERTY SECURITY INTEREST** (this "Release") is made by Wilmington Trust Company ("Grantee") and is effective as of May 31, 2011 (the "Effective Date").

**WHEREAS**, Momentive Specialty Chemicals Inc. (formerly known as Hexion Specialty Chemicals, Inc. and Borden Chemical, Inc., and successor to Resolution Performance Products LLC, Bakelite Epoxy Polymers Corporation, Bakelite North America Holding Company, BDS Two, Inc., Resolutions' JV LLC, Resolution Specialty Materials Capital Corp. and Resolution Specialty Materials LLC), Momentive Specialty Chemicals Holdings LLC (formerly known as Hexion LLC), Borden Chemical Foundry, LLC, Momentive Specialty Chemicals Investments, Inc. (formerly known as Borden Chemical Investments, Inc.), Hexion U.S. Finance Corp. (formerly known as Borden U.S. Finance Corp.), HSC Capital Corporation (formerly known as RPP Capital Corporation), Lawter International Inc., Momentive International Inc. (formerly known as Borden Chemical International, Inc.), Oilfield Technology Group, Inc., and Momentive CI Holding Company (China) LLC (formerly known as Hexion CI Holding Company (China) LLC) (collectively, as applicable, "Grantor") and Grantee are party to that certain Collateral Agreement (the "Collateral Agreement") dated as of November 3, 2006.

**WHEREAS**, pursuant to the terms and conditions of the Collateral Agreement and those certain trademark security agreements by and between Grantor and Grantee (1) executed and recorded August 31, 2005 at Reel/Frame 3153/0940; and (2) executed November 3, 2006 and recorded on November 21, 2006 at Reel/Frame 3432/0035 (collectively the "Intellectual Property Security Agreements"), Grantor granted to Grantee a continuing security interest in, to and under all of Grantor's right, title and interest in the United States trademark registrations and applications set forth on Schedule A attached hereto (collectively, the "Intellectual Property").

**WHEREAS**, while the Collateral Agreement otherwise remains in full force and effect, Grantee now desires to confirm the termination and release of its security interest in the Intellectual Property.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby terminates, cancels and releases any and all security interests it has against the Intellectual Property and hereby assigns and transfers any and all interest Grantee may have in and to the Intellectual Property.

Grantee shall at Grantor's expense, take all further actions, and provide to Grantor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Grantor to more fully and effectively effectuate the purposes of this Release.


